

# Privacy Policy

Effective date: October 1, 2019

GC Mogam, Inc. operates the <http://GCMogam.com/> website (the "Service")

This page informs you of our policies regarding the collection, use, and disclosure of personal data when you use the Service and the choices you have associated with such collection, use and disclosure.

We use your data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this policy.

## Information Collection and Use

We collect several different types of information for various purposes to provide and improve our Service to you.

## Types of Data Collected

### PERSONAL DATA

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personal Data may include, but is not limited to:

Your email address

Your first and last name

Cookies and Usage Data (see below)

We may use your Personal Data to contact you with newsletters, marketing or promotional materials and other information that may be of interest to you. You may opt out of receiving any, or all, of these communications from us by following the unsubscribe link or the instructions provided in any email we send.

### USAGE DATA

We may also collect information on how the Service is accessed and used ("Usage Data"). This Usage Data may include information such as your computer Internet Protocol (IP) address, browser type and version, the pages of our Service that you visit, the time and

date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

## LOCATION DATA

We may use and store information about your location if you give us permission to do so ("Location Data"). We use this data to provide you with features of our Service and to improve and customize our Service.

You can enable or disable location services when you use our Service at any time by way of your device settings.

## TRACKING & COOKIES DATA

Cookies are files with a small amount of data that may include an anonymous unique identifier but contain no Personal Data. Cookies are sent to your browser from a website and stored on your device.

We use cookies and similar tracking technologies, such as beacons, tags and scripts to track the activity on our Service and we retain certain information they provide.

You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Service.

### Examples of Cookies we use:

- **Session Cookies** - We use Session Cookies to operate our Service.
- **Preference Cookies** - We use Preference Cookies to remember your preferences and various settings.
- **Security Cookies** - We use Security Cookies for security purposes.

### Use of Data

GC Mogam, Inc. uses the collected data for various purposes:

- To provide and maintain our Service
- To notify you about changes to our Service

- To gather analysis or valuable information so that we can improve our Service

- To monitor the usage of our Service
- To detect, prevent and address technical issues

## Retention of Data

GC Mogam, Inc. will retain your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes and enforce our legal agreements and policies.

GC Mogam, Inc. will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period, except when this data is used to strengthen the security or to improve the functionality of our Service, or we are legally obligated to retain this data for longer periods.

## Transfer of Data

Your information, including Personal Data, may be transferred to and maintained on computers located outside of your state, province, country or other governmental jurisdiction where the data protection laws may differ from those of your jurisdiction.

If you are located outside of the United States and choose to provide information to us, please note that we maintain the data, including Personal Data, in the United States and process it there.

Your consent to this Privacy Policy followed by your submission of such information represents your agreement to the foregoing.

GC Mogam, Inc. will take all the steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organization or a country unless there are adequate controls in place including the security of your data and other personal information.

## Disclosure of Data

GC Mogam, Inc. may disclose your Personal Data in the good faith belief that such action is necessary to:

To comply with a legal obligation

To protect and defend the rights or property of GC Mogam, Inc.

To prevent or investigate possible wrongdoing in connection with the Service

To protect the personal safety of users of the Service or the public

To protect against legal liability

## Security of Data

The security of your data is important to us but no method of transmission over the Internet or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your Personal Data, we cannot guarantee its absolute security.

## Do Not Track Signals

We do not support Do Not Track, a preference you can set in your web browser to inform websites that you do not want to be tracked.

## Your Data Protection Rights

Please note that we may ask you to verify your identity before responding to such requests.

EU residents have the right to complain to a Data Protection Authority about our collection and use of your Personal Data. For more information, EU residents should contact their local data protection authority.

## Service Providers

We may employ third party companies and individuals to facilitate our Service ("Service Providers"), provide the Service on our behalf, perform Service-related services or assist us in analyzing how our Service is used.

These Service Providers will have access to your Personal Data only to perform these tasks on our behalf and will be obligated not to disclose or use it for any other purpose.

## Analytics

We may use third-party Service Providers to monitor and analyze the use of our Service.

Google Analytics is a web analytics service offered by Google that tracks and reports website traffic. Google uses the data collected to track and monitor the use of our Service. This data is shared with other Google services. Google may use the collected data to contextualize and personalize the ads of its own advertising network. You can opt-out of having made your activity on the Service available to Google Analytics by installing the Google Analytics opt-out browser add-on. The add-on prevents the Google Analytics JavaScript from sharing information with Google Analytics about your activity on the Service.
